#### **State & Federal Watch**

Changes to CME Requirements in NC Effective August 1

On Wednesday, August 1, 2012, new rules took effect regarding the Continuing Medical Education (CME) requirements for North Carolina Medical Board (NCMB) licensees. These NCMB rules reduce the number of CME hours required from 150 every three years to 60. This change will bring NCMB standards more in line with other states by completely eliminating Category II, or physician-initiated, CME. In addition, the rules also give providers credit for board certification activities.

### **Solve the Clinical Puzzle**

Burnout and Satisfaction With Work-Life Balance Among US Physicians Relative to the General US Population

Despite extensive data about physician burnout, no national study has previously evaluated rates of burnout among US physicians, explored differences by specialty, or compared physicians with US workers in other fields.

Significant findings concluded that compared with high school graduates, individuals with an MD or DO degree were at increased risk for burnout, whereas individuals with a bachelor's degree, master's degree or professional or doctoral degree other than an MD or DO degree were at lower risk for burnout.
